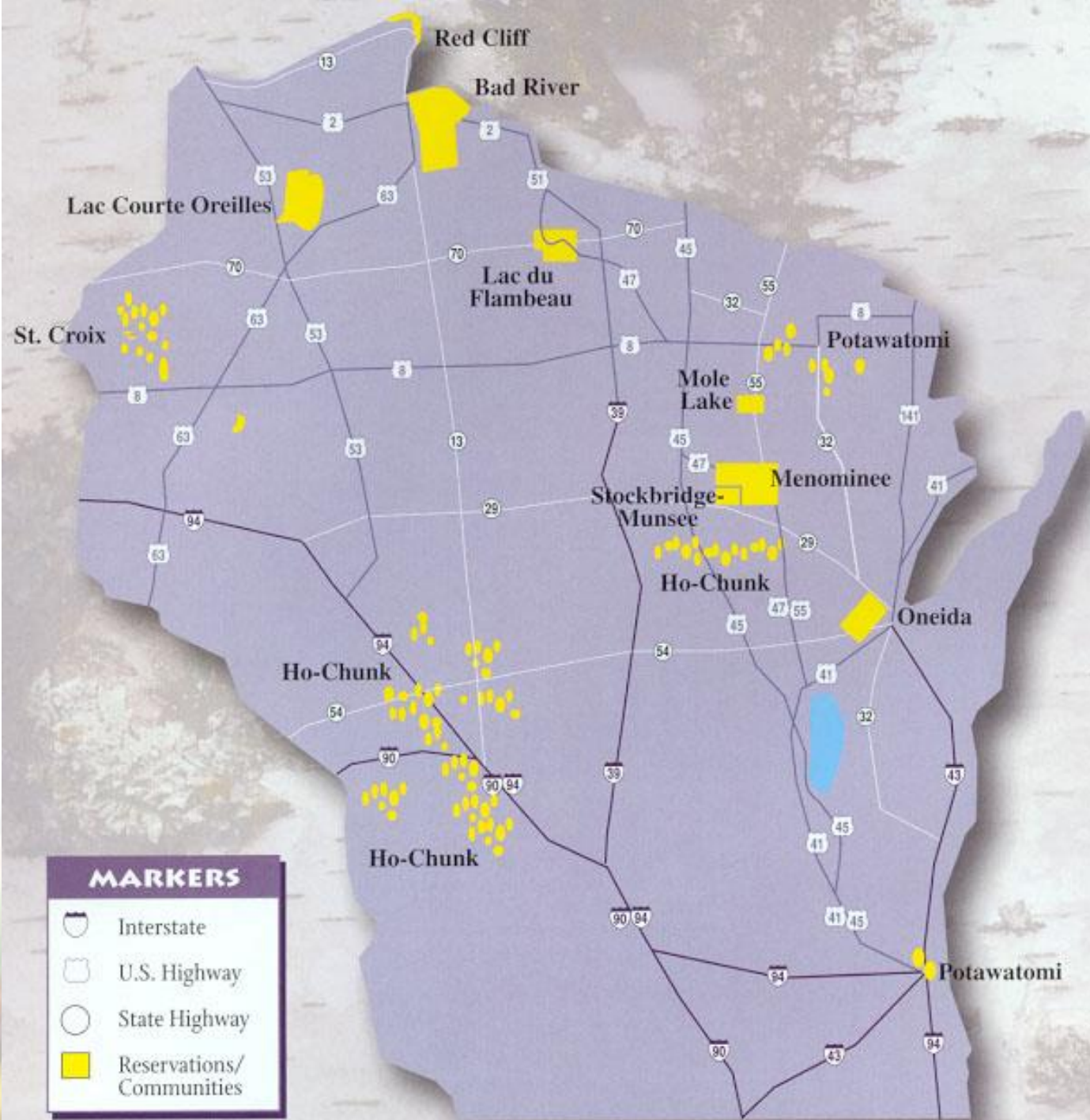


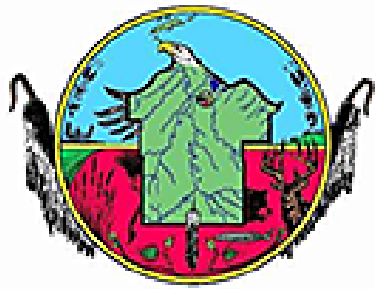

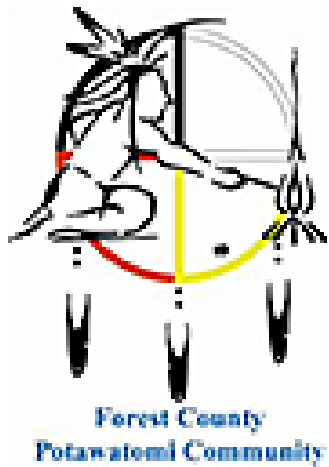

OTHER ECONOMIC DEVELOPMENT PROGRAMS

- The Buy Indian Act
 - Used by IHS and BIA
- Indian Preference
 - BIA and HIS Only
 - Individual Tribal Government
- The Indian Incentive Program
 - 5% bonus to contractors using Indian Businesses
 - DOD contracts over \$500,000
