Colonel Paul Mazure is the commander for Defense Contract Management Agency (DCMA) Chicago, which is a joint service defense acquisition organization responsible for the leadership, operations and control of approximately 289 civilian and 9 military personnel, spanning over a five state Midwestern geographic area (approximately 271,000 square miles). Colonel Mazure's responsibilities include leading and managing the efforts for contracts management and acquisition life cycle support to all DoD Services and Agencies for 10,071 contracts valued at \$70.4 billion. DCMA Chicago covers 761 contractor production facilities and is responsible for the cost, schedule, performance and operational readiness support to Program Managers, Buying Commands and the Defense Logistics Agency. Supported Programs include DoD ACAT I Programs like the Joint Light Tactical Vehicle and the Common Infrared Countermeasures Programs; Joint Munitions; rotary and fixed wing aircraft parts and refits; Soldier support systems; and NASA.

In addition, the command supports end to end product lines shipped directly to the warfighter in support of theater requirements and is a center stakeholder in coordinating contractor, DCAA, DFAS, & Prime/sub-tier supplier actions in support of the DoD Acquisition Enterprise. Colonel Mazure's responsibilities also includes interfacing with industry groups as the government's senior representative.
